



2024 Advocacy & Policy Accomplishments

- Implementation of historic across-the-board investments in the Medicaid community behavioral health service rates to sustain access and stabilize the workforce.
- Advocated for improvements in Medicaid provider enrollment, credentialing, re-validation processes, and claims payment issues to enhance functionality and implementation.
- Advocated for distribution of behavioral health workforce investments through the Great Minds Fellowship and improved collaboration with institutions of higher education.
- Developed a mental health credential strategy in collaboration with members to create clear career pathways for individuals interested in mental health services, aligning with the Ohio BH Workforce Strategic Plan.
- Strengthened the partnership between the Ohio Department of Insurance and the Ohio Parity Coalition to target actions to address BH workforce and service access challenges.
- Advanced state policy initiatives to develop and establish an Ohio CCBHC model.
- Engaged with OhioMHAS and system stakeholders to address ADAMHS Boards' contracting requirements in Chapter 340 and promote
 collaborative community planning.
- Collaborated with OhioMHAS and the National Council to identify innovative policy and practice strategies using a rapid-cycle change process to improve access to care.
- Promoted the expansion of school-based behavioral health services through partnerships with schools to enhance access to prevention, consultation, and treatment services for youth and families while optimizing the behavioral health workforce.
- Supported substance use services through continued engagement and participation with the 1115 SUD Waiver Advisory Committee;
 promoted and supported opioid use disorder treatment policy and regulatory reforms, and enhanced state and federal funding.
- Collaborated on policy recommendations to strengthen OhioRISE as a systems of care model to meet the needs of multi-system engaged youth and families while supporting implementation of the new Department of Children and Youth.
- Partnered with Ohio's Centers of Excellence and the Ohio Suicide Prevention Foundation to promote and expand practice-based learning opportunities and workforce development.
- Advocated for policies and investments to support 9-8-8 and development of the crisis continuum.
- Supported efforts to implement national accreditation for recovery housing, improve credentialing and reimbursement for peer recovery services, and enhance supported employment policies and payments.
- Fostered membership growth through strong policy advocacy, high value membership engagement opportunities, and responsive training and technical assistance.

2025 Advocacy Priorities

- Advance strategies and strengthen investments in the behavioral health workforce and human infrastructure including continuation of education and career development funding and implementation of the qualified mental health credentials.
- Expand enforcement of insurance parity for mental health and substance use services through collaboration with the Ohio Department of Insurance and U.S. Department of Labor.
- · Accelerate policy and practice change that makes engagement a priority and access easier.
- Leverage data and technology innovation to improve care, care coordination, and health outcomes.
- Maintain and enhance investments in a full continuum of behavioral health services and supports in collaboration with system partners in the SFY 2026-2027 state budget.
 - Define the economic impact and necessity of investment in mental health and substance use services to support a thriving economy.
 - Maintain and enhance Medicaid investments in community behavioral health services and supports.
 - Develop and fully fund Ohio's CCBHC model of care and continuum of crisis services, including 9-8-8.
 - Expand investment in school-community BH provider partnerships to support healthy students and educators.
 - Create a dedicated and stable funding stream for prevention, harm reduction, and early intervention.
 - Improve outcomes and recovery through access to healthy and safe housing options, meaningful employment opportunities, and peer recovery support services.
