The OhioMHAS Bureau of Grants Administration is disseminating reminder notices regarding the deadline to submit final disbursement requests in GFMS and steps necessary for the grant closeout process for SOR 2.2 and SOR Carryover.

For awardees who have expended the full award by 9/29/2022, please complete end-of-year report and submit a final expenditure report in GFMS by Wednesday, 11/30/2022. Awardees who do not expend the full award by 9/29/2022, please follow the steps and timeline below:

Final Grant Closeout Timeline:

Thursday, 09/29/2022	Last day for SOR 2.2 and Carryover expenditures and services to be completed.
Wednesday, 10/05/2022	End-of-year report and impact stories due to OhioMHAS.
Monday, 11/14/2022	Deadline to submit final GFMS disbursement request for SOR 2.2 and Carryover.
Monday, 11/21/2022	Awardees that have not expended their full awards will be placed into revision status in GFMS to allow changes to the face sheet and final budget.
	A final expenditure report for the grant programmatic period of 9/30/2021 to 9/29/2022 must be submitted in GFMS on or before 11/30/2022.
Wednesday, 11/30/2022	Deadline to submit GFMS revisions for updated face sheet amount, final budget expenditures, and submission of final grant expenditure reports.
Wednesday, 12/28/2022	Final NOSAs will be issued to reflect actual grant expenditures. Issuance of final NOSAs will officially closeout <u>ALL</u> SOR 2.2 and SOR Carryover grants.
