**Description:** The ASAM Criteria Fourth Edition uses a holistic, person-centered approach to determining the appropriate level of care and developing individualized treatment plans for clients with substance use disorders (SUDs) and co-occurring conditions. This training will introduce core components of the ASAM Criteria, along with Fourth Edition updates to level of care assessment, decision rules, and continuum of care. Didactic material and case scenarios will be used to illustrate ASAM's six dimensions and how multidimensional assessments are used to develop appropriate level of care recommendations and person-centered treatment plans that consider each client's unique biomedical, psychological, and sociocultural context.

#### **Objectives:**

- (1) Describe core components of ASAM Criteria, including (a) level of care assessment, (b) decision rules, and (c) continuum of care.
- (2) Introduce 4<sup>th</sup> Edition updates, including new terminology, levels of care, and guiding principles.
